Debra Mieszala, Certified Genealogist[®], has been involved in genealogical research for over twenty-five years. Much of her work involves locating family members of past war MIAs for the Army and Air Force. She formerly worked under court order as a certified Confidential Intermediary (CI) in Illinois, assisting people in adoption situations to re-connect. In addition to presenting at the national conference level, she has taught classes at Salt Lake Institute of Genealogy. Her articles have been published in *OnBoard!*, *NGS Magazine*, and *The Digital Genealogist*.

~**Wonderful Websites: Real Records Online** Original records can be found online. Scattered and varied, their value is immense. Several sites will be reviewed.

~**The Curious Case of the Disappearing Dude** James McBride seemingly vanished after coming of age. This case study presents how multiple versions of obituaries and other records helped uncover a name change, discover a famous James, and identify what became of his kin.

~**Pension Application Files** Military pension application files are invaluable resources of genealogical and historical information. Many pension application documents are preserved and contain valuable data. The various laws that governed pensions will be discussed.

~**Pulling Evidence from Beneath a Record's Surface Information** Proper scrutiny of each piece of information in a document is essential to understanding that item's evidentiary value. Studying every word's meaning and context ensures that evidence has been properly analyzed and comprehended. Includes a sample research problem and documents to puzzle through in class.

GRAND OPENING OF LIBRARY

HOORAY! THE GFO LIBRARY IS OPEN!

On September 14th, 2011, folks gathered in the lobby just outside the new library's open double doors for the opening ceremonies. Laurel Smith and her band of volunteers had arranged chairs, tables of cookies (donated by Rawlicious and the Ford Food restaurant upstairs), pickled vegetables (donated by our local "pickle man" for Moonbrine Pickles), and hot tea from fellow tenant Foxfire Teas which is located at the back of the Ford Building. The library doors were propped back and supported clusters of colorful balloons. A wide red ribbon, strung across the entry way to the library, was cut by President Lyleth Winther and Bob Hastings of TriMet at the close of the ceremony.

Don Holznagel, Relocation Chair emceed the event, reflecting on the three year long process, recognizing Jim Morrow, our Facilities Manager and Interior Design Chair, the vendors and our realtors who help find our space. President Winther welcomed everyone, and declared "We, the board and volunteers, are excited, we hope you are. There are several details to be worked out, but we are glad the move is over and we are back open. We appreciate all the hard work the committees contributed--from planning to painting parties, to setup in the new space". From TriMet's Bob Hastings, a TriMet Agency Architect, we were presented with the progress so far on the Milwaukie MAX line, as well as a visual aid showing what the transformed area will look like as he pointed out the space where the Gideon building will be only a memory. The Gideon Street building next to the railroad was to be demolished this fall, but there have been delays.

Historic Scrapbook Presented: At the Grand Opening Event, in honor of the Grand Opening, Bonnie LaDoe, of the Heritage Scrapbooking Interest Group, presented Lyleth and the society with a scrapbook of the early days of the Ford Building itself, our moving events like the painting parties, and a wealth of clippings and souvenirs from the very early days of the Genealogical Forum of Oregon from when it was formed in 1946. It can be found atop a short bank of shelves near the main desk.

HIGHLIGHTS OF LESLIE LAWSON'S TRIP TO THE 2011 FGS CONFERENCE

The week of September 5th I flew to Springfield, Illinois for the FGS conference. It was a wonderful conference where I had a great time.

There were over 2000 in attendance. I'm working to transcribe all my notes and ideas I came away with that week and wanted to include some here, as I think some of these might be useful to growing our society as well.

I also got to see Kristy Gravlin several times and a few other Oregonians.

One of the items that gives food for thought is genealogy tourism. There was an award given for what Oklahoma was able to do to bring tourism dollars to their state. Here is a link to the award announcement and it has links within it to Oklahoma. This of course is driven by advertising and partnering with the tourism board.

One of the lectures I attended was by D. Joshua Taylor, "**Engaging a New Generation of Genealogists.**" The buzz after this lecture went till the next lectures began an half hour later! I'll be including notes below, but here is a blog post that explains well the gist of the lecture.

And, out of that lecture we have a new word, 21sters. Who are the 21sters? They are the younger people who come to us fully connected in the 21st century with the ability to use social media and the electronics that drive social media.

Here are some of the ideas presented in the lecture that I hope can be of some benefit to GFO.

- Make Mentoring a benefit of membership. This helps to engage the membership and nurture the new member to be better researchers through education.
- Ticketed event: It was explained that the younger generation of today buys event tickets all the time. It is the same as registration, but in the terminology of the 21ster, you get event tickets.
- Have online learning tools on the website. These might include webinars; or lessons on how to do a particular research task.
- As a benefit of membership, if your members are on Google+ the society can sponsor a 'hang-out' (all free on Google+). You can create a calendar of subjects that you might discuss. Keep in mind there is a 10 person limit to hangouts.
- Create YouTube items for the benefit of your society. Perhaps a tour of your society from the prospective of the potential new member (this of course removes the fear of the unknown when someone watches the introduction of the society from home, so everything will look some what familiar when they come thru that door.) Go to
- youtube.com and search with the word genealogy.
- Have an official society blogger, preferably a 21ster.
- Have a Google+ coordinator
- Have a Twitter society rep as well.

- Involve the Community: develop mentorship programs for 21sters Involve librarians; History students at local colleges, Archivists, student archivists - invite them to speak at our society (and expose them to this part of history), Society of American Archivists. Historians, History students as above, Schools: Family History projects, Teachers & Administrators, History & Social Studies Classes. Sponsor events having to do with family history.

21st Century Marketing for Genealogy Societies : lecture by Thomas MacEntee (yes there's more!) Social Media tools are needed to get the attention of the younger people and make your community aware of your presence. Much of what he talked about is above in the notes from Josh's presentation. All those electronic formats are needed; Facebook, Twitter, LinkedIn, Blogs, Videos, Social bookmarking.

Thomas has a Social Media Plan that he says should be implemented slowly, say every other month adding something. I've written to Thomas and requested this plan. (It's information). I believe in always gathering more information.

GFO Writing Contest 2012 – “Taking a Stand”

The Writing Contests' theme this year is “Taking a Stand.” All of us have ancestors who took a stand, sometimes risking their lives; or at the very least, risking their position in the community. It took courage and conviction, and should make for very interesting stories this year. As last year, awards will be made at the GFO's April 14th monthly meeting. See the rules below for the rules and due date.

You most likely have people in your ancestry that would fit well with this theme. I can think of at least three examples from my own family history.

1. John Emery, one of the original settlers in Newbury, Massachusetts, was hauled into court for “entertaining Quakers.” He said that “if they came to his house they should be welcome and he would not forbid them.” He was accused of bringing “scandal... upon our town to the dishonor of God and damage and hurt to some of our neighbors”.

2. Joshua Rea, living in Salem Village (now Danbury), during the Witchcraft trials in 1692-3, signed a petition to get charges dropped for seventy-year old Rebecca Nurse. At first it looked like Rebecca had been exonerated. But the teenagers, who had accused her in the first place, began to have unexplainable fits, and in the end she was hung.

The Baldwin and related families, in Morris Township and Amherst Township, Washington County, Pennsylvania, in the 1830s, helped transform their Presbyterian Churches to Cumberland Presbyterian, turning away from the concept of “predestination” and from requiring ministers to have significant education. Both stands were fitting for a frontier community, where they believed in their ability to make a good life and where it was difficult to get educated ministers to come.

There is real drama in all three of these stories, allowing for good character development and intriguing plots. Look for families and individuals in your own family history that would make for a good factual story.

You will want to include particulars about your ancestors, building your story's characters, so we can see them as we read. You will also want to build the environment, what it was like in your ancestor's place and time. You will want to build a plot with suspense, that includes the adversity, and the risk that your ancestor took by “taking a stand.” Why would they take the stand they did? What was going on in their environment that would lead them to act in the way they did.
